Re: UNMIK Special Operations Group

Dear Secretary General Annan:

Due to my work on the 9-11 Truth Movement, I have had a wide variety of substantive fact witnesses come forward regarding the attack on the United States on September 11, 2001.

I met Bidas Corporation {Argentina} in 1999 at a telecom conference and knew about their 1997 lawsuit in Texas against Unocal, their appeal against Turkmenneft that they won on September 9, 2003 at the Fifth Circuit, U.S. Court of Appeals, [*Bidas SAPIC v. Government of Turkmenistan, et al.*, No. 02-20929, 5<sup>th</sup> Cir] and the Turkmenneft appeal to the U.S. Supreme Court that was denied on March 22, 2004, Case 03-1018, *Turkmenneft v Bidas SAPIC*.

In that regards, one group came forward to me and other prosecutors regarding a flight that left Kosovo on 9-11-2001 with a large amount of cash on board and which the UNMIK Special Operations Group provided security for the delivery of that cash. That cash was purportedly delivered to either Gulbuddin Hekmatyar or General Rashid Dostum [or both] as part of the overall 9-11 / Afghanistan pipeline takeover strategy.

In short, part of the "official story" is not complete, is not accurate nor is it honest in its content.

We know that Todd Engstrom [now deceased] was on that flight and we insist that your organization provide the identities of and protection for the other UNMIK Special Operations Group personnel that were on that flight. Mr. Engstrom was UNMIK Special Operations Group before he returned to the U.S. and redeployed with Blackwater USA to Iraq. He was killed in September 2004 in Iraq. Both facts - his role with UNMIK and his death in Iraq are established facts.

As Mr. Engstrom was a member of UNMIK SOG and on a post 9-11 Pay-Off Flight, this matter sits squarely on your desk.

You should note that we have provided copies of this letter to Interpol, the FBI, and the offices of Eliot Spitzer, Attorney General for the State of New York and Robert Morgenthau, District Attorney for Manhattan. We have also provided copies of this letter to the Commonwealth Attorney for Arlington County, Virginia, since part of the crime of 9-11 was perpetrated against that state as well.

Americans demand answers and the world demands answers regarding 9-11, who did it and why they did it. The translations by FBI translator Sibel D. Edmonds were not in Arabic, they were in Farsi, Turkish and Azeri regarding “drug trafficking, money laundering, foreign names and American names” as being directly involved in the planning, financing and execution of September 11, 2001.

That such a large amount of cash was “in position”, ready to send east from Kosovo within hours after 9-11 is a matter that deserves your attention and that of other nations who either lost citizens on 9-11 or have borne the brunt of the after effects of 9-11. Such preparedness is indicative of foreknowledge that 9-11 was going to happen.

It is time for you and other elected leaders to come clean with the truth and let the public decide the fate of those involved in 9-11 and the fate of those that have worked diligently to cover it up. Justice will be done and as a leader it is time for you to lead. Therefore, we respectfully ask that you do your job and provide the full identities of who was on that flight and provide protection for any and all parties that were on the flight but have not been eliminated such as Mr. Engstrom has been.

This is an issue that is not going away, and in fact is just now going to become a focal point of resolving 9-11 and bringing many to justice.

The Engstrom matter is Part VI of a series titled *Pop Goes the Bush Mythology Bubble*. Part V just broke on February 2, 2005 and addresses the myth that Flight 77 hit the Pentagon.
