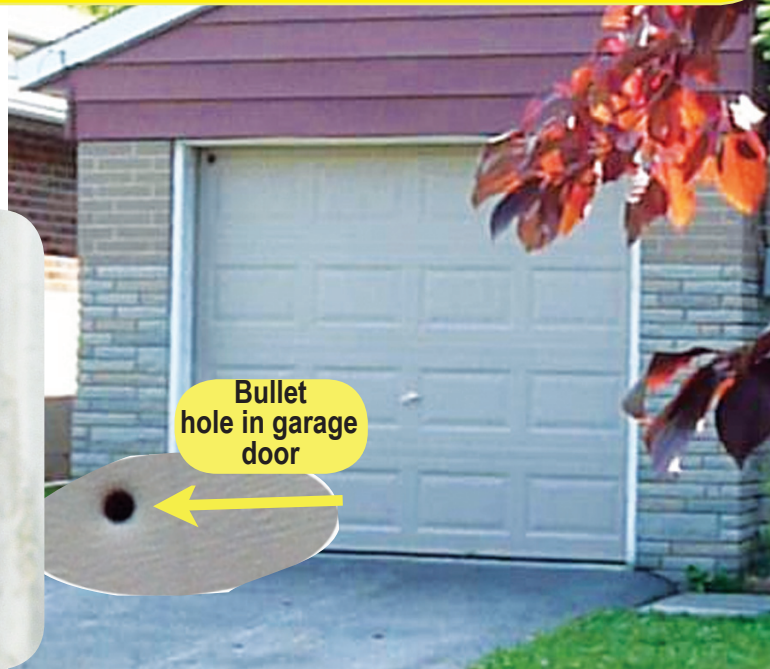


## **Family devastated, household terrorized as police kill woman in front of house, then traumatize tenant in bed by pointing gun in his face & showing pepper spray & tasers**

Lithuanian victim of police shooting Oct. 7, 9:30 a.m. Sylvia Wasowicz recently considered time in a nunnery as part of her spiritual calling.

As her health deteriorated, she maintained her giving efforts and volunteered for seniors, etc. She helped all in her circle according to those relatives and friends closest to her in recent months as interviewed by *Toronto Street News*.

One of the tenants in the house experienced his room being raided by 3 police personnel, one with a drawn gun in his face and two others displaying their belts with tasers and pepper sprayers. Having his foot grabbed while in bed, Warren (pictured at right) appeared at the funeral Oct. 14 in a traumatized state unable to sleep more than twice since the shooting and home invasion by police. Following Sylvia's shooting by police (3 to 5 shots) who claim she was brandishing a knife, she ran from the house at 51 Wedgewood to 44 before collapsing in middle of street. The family had not called police for any domestic dispute and are mystified as to who called police for such an unnecessary tragedy as this.



Two marked police cars appeared at night although SIU was assigned to investigate.

***"I had a premonition that I would be murdered."***

**Police claim arsonist set explosive fire at 4 am with cigarette butt! Why were phone lines cut before flames appeared outside of closed concrete building.?**

**Editor's car exploded 30 seconds after he withdrew from smoke-filled garage (no flames) narrowly escaping instant death! 911 phones had already failed.**



No further investigation has been carried out. Our own ongoing investigation will reveal answers expected in the new year.

When we reported that a ladder was also stolen #55 Division Police Detective White told us that if the garage was left open until the Fire Marshal's Office allowed us to close it and clean up 4 weeks later we could expect thefts.

Are Toronto citizens therefore being accused of being common thieves?

Will Torontonians 'naturally steal' anything left on a front or back porch?

The auto shown above was in a closed garage with no entrance except by climbing over a fence. Flames could escape only at the front later on where there were no phone lines near the flames until well after the explosion.

Did the arsonist know that I would be attending my uncle's funeral 80 miles away just before the fire and would be exhausted in deep sleep?

Why did the fire occur at the same time that the McGuinty government cancelled the Mega-Quarry clearance for a 2 year environmental study being protested repeatedly?

Did an anti-Mega-Quarry protester get his barn burned for a similar reason last week?

Detective White needs sophistication in her training.

Why should Torontonians take it for granted that car fires are ignited by cigarette butts and phone lines may stop working for no particular reason at the same time? Is it possible to take it for granted that no city service can be relied upon for professional expertise?

Perhaps we should not have called 911 at all from another address and let things burn away. Why bother to report anything? The house almost burnt as well as the loudly roaring explosive flames came out 7 feet horizontally threatening the house for 24 seconds.

More positively, the Fire Marshal's office did pay attention to our plight and spent serious time investigating. Street police (not the detective) who attended also asked us questions requiring descriptive answers and were told that the phone lines were cut.

The private insurance engineer who investigated was thorough as well and concluded it was necessary to also acquire a protest sign against the quarry since that the mega-quarry is near the investigator's home in Mono Mills north of Toronto. Our NDACT.

com sign on the garage survived the arson attack intact but scorched.

Perhaps Detective White should read a newspaper to know what goes on in her community's corporations and the U.S. and Israeli needs for massive clean Ontario quarry water supplies since the Mega-Quarry will have a railroad link to international lake access export ports in Owen Sound and Toronto.

The Shelburne mega-quarry's mayor announced that the Mega-Quarry is his biggest customer so he cannot comment on the dangers of the quarry water theft to foreigners.

300 copies of Bob Rae-Levine scandals issue were burnt before mailing.
