

## Notice to:

**South African National Government, African National Congress, African National Youth League, Economic Freedom Front, Democratic Alliance, Black First Land First and any affiliated parties, groups, companies and individuals that have chosen to aid, abet and/or align themselves to them.**



- All properties that are on our soil from declaration of secession date will be effectively the property of the country in lieu of the trillions that has been stolen.




